I fell off my chair at the meeting when Vollmer laughed over his definition of kids occasionally using drugs, so I missed Barbara Donvan agreeing with him. However, I did catch the jewel of the evening when Jenny Vervynck directed staff to research her idea, a Charter School for the expelled students (all 90 of them) and Lance's recreational drug users.

We the parents fear our children sitting in the classroom with the "recreational drug users." We fear these "student lawbreakers" selling drugs to our children, enticing our children to start on any drugs including cigarettes. We do not want our children sitting next to kids who are allowed to have a water bottle filled with vodka, and beer. We do not want weapons on campus, we do not want marijuana on campus, we do no want violence on campus. We do not want a Charter school or expelled students and "recreational drugusers."

The LIBERALS are at it again, they have decided to save the student who isn't doing his job, rather than all the kids who are.
